### 1. <u>DEPARTMENT OF AGING</u> Senior Center Capital Improvement Grant

Recommendation:	That the Board of Public Works approve waiving the State's right of recovery against parties other than Baltimore County and the Cockeysville Senior Center, and so render moot the requirement to record a notice of that right in local land records.
Authority:	Human Services Article, Annotated Code of Maryland, §§ 10-501-10-510 and COMAR 32.03.01
Prior Approval:	Secretary's Agenda, Item 6 (12/2/2020)
Grant Recipient:	Baltimore County
Fund Source:	2019 MCCBL

**Remarks:** In 2018, Baltimore County applied for a \$90,000 grant under the Senior Citizen Activities Centers Capital Improvement Grants Program to help finance the renovation of the roof of the Cockeysville Senior Center. The senior center is on a 12,900 square foot piece of property that Baltimore County leased for 50 years from the Cockeysville Elementary Limited Partnership. On October 5, 2020, the roof renovation project was completed, and on December 2, 2020, the Board of Public Works approved the award of the \$90,000 grant.

HSA § 10-506(a) provides that before State funds are paid under the program, a grantee shall record in the local land records a notice of the State's statutory right to recover a pro-rata portion of the grant funds if certain conditions of HSA § 10-507 are not met. Although the application for the grant provided that a notice of the right of recovery would be recorded, Baltimore County has been unable to file the notice because: (i) HSA § 501(h)(3) requires that any lessor of the property consent to the recordation, and (ii) the lessor, Cockeysville Elementary Limited Partnership, will not consent. The Cockeysville Elementary Limited Partnership is concerned that agreeing to the right of recovery may conflict with certain financing agreements secured by the property.

HSA § 10-509(g) authorizes the Board of Public Works to waive the State's right of recovery if the Board determines that there is good cause for releasing the transferor, transferee, or owner from this obligation.



#### Remarks (cont'd):

In order to resolve the dilemma described above, Baltimore County has agreed to enter into a grant agreement that expressly preserves the State's right to recover the grant funds from Baltimore County in the event of a default, if the Board of Public Works finds that good cause exists to waive the recording of the notice of the State's right of recovery in the land records.

The Office of the Attorney General has reviewed the grant agreement and approved it for legal sufficiency.







*Remarks*: *Conviction*. In 1985 the Baltimore County Circuit Court convicted Mr. Kirk Bloodsworth of 1<sup>st</sup> Degree murder,1<sup>st</sup> Degree Rape and 1<sup>st</sup> Degree Sexual Assault, for which he was initially sentenced to death; and at a later retrial, to life in prison.

*Release & Initial Compensation.* In 1993, Mr. Bloodsworth was released after becoming the first US Death Row inmate exonerated by DNA evidence. He received a pardon from Governor Schaefer later that year, and in 1994 the Board of Public Works granted him compensation in the amount of \$300,000. See Department of Budget and Fiscal Planning Item, 51-GM (06/22/1994).

Supplemental Compensation. Upon passage of the Walter Lomax Act (Chapter 76, Laws of Maryland 2021), the statute for these grants was amended to adopt the formula used by this Board in determining compensation for grantees, specifically compensation in the amount of the daily rate of the State's most recent annual median household income as published in the American Community Survey of the U.S. Census Bureau in the year the order of eligibility is issued and divided by 365 days to the nearest whole cent. Furthermore, the statute provides that "An individual who was awarded compensation under this section on or before July 1, 2005, may request an order for supplemental compensation in the amount authorized by this section on or before July 12, 2023.

At a hearing before an Administrative Law Judge, it was stipulated by Mr. Bloodsworth and the Office of the Attorney General that: (1) Mr. Bloodsworth was confined for 3,035 days, (2) the most recent annual median household income is \$86,738, (3) the statutory formula compensation amount is \$721,237.40, and (4) the \$300,000 previously granted to Mr. Bloodsworth by the Board of Public Works should be subtracted from the statutory formula compensation amount. Following the hearing, the Administrative Law Judge found the amount of supplemental compensation Mr. Bloodsworth is entitled to is \$421,237.40.

*Recommended Expedited Payment Schedule.* Under SFP § 10-501(d)(1)(iv), if an Administrative Law Judge determines that an expedited payment schedule is in the best interests of the exoneree, they are to recommend an expedited schedule in their order. The decision *In the Matter of the Wrongful Conviction of Kirk Bloodsworth, Claimant v. Board of Public Works* included a recommended expedited payment schedule of: \$86,738.00 paid within sixty days of the final decision; \$13,262.00 paid by December 31, 2021; and a final payment of \$321,237.40 paid by April 31, 2022 [sic].





### Remarks (cont'd):

Attorney's Fees. Under SFP § 10-501(d)(1), orders for compensation and benefits shall include reasonable attorney's fees and expenses associated with the action brought under this section. The decision *In the Matter of the Wrongful Conviction of Kirk Bloodsworth, Claimant v. Board of Public Works* ordered payment of attorney's fees in the amount of \$31,343.90.

The Department of Budget and Management has recommended the Board of Public Works pay ordered attorney's fees upon approval by the General Assembly of a deficiency appropriation into the FY 2022 Operating Budget.





#### 7. <u>BOARD OF PUBLIC WORKS</u> Wetlands Licenses



### ANNE ARUNDEL COUNTY

20-1533 *WILLIAM HARRIS* – To reduce shoreline erosion by installing a stone groin. *Pasadena, Chesapeake Bay* 

Special conditions: None.

*Application:* The property of Mr. William Harris, the applicant, contains 225 linear feet of shoreline on the Chesapeake Bay, with no existing erosion control structures. Mr. Harris has applied for a State tidal wetlands license to install a 41.66 linear foot groin on his property.

**Public Comment to the Board:** Ms. Elizabeth Anderson, an adjacent property owner, opposes the issuance of the proposed license. Ms. Anderson has stated concerns regarding: 1) potential negative affects to her property from the installation of the groin, and 2) disputes that the waiver of the living shoreline legal requirement was properly granted.

*Wetlands Administrator's Review:* The Board of Public Works' Wetlands Administrator reviewed MDE's Report and Recommendation and the comments submitted, had discussions with the applicant, the interested persons, and a coastal engineer, and visited the site.

**Response to 1**. The Administrator believes that sand transport will be changed by the addition of the groin. Specifically, it is likely Ms. Anderson's property will benefit from sand accumulation in the summer, but not in the winter and especially not during nor'easters. The groin length proposed is expected to create less sand transport and/or less disruption to the sediment transport system than the longer groins upcoast of Mr. Harris's property.



### 8. <u>BOARD OF PUBLIC WORKS</u> (cont'd)

#### Wetlands Administrator's Review (cont'd):

**Response to 2**: MDE issued a Living Shoreline waiver for the project due to the project's substantial fetch, which is the distance wind travels across open water. The fetch at Mr. Harris's property is northeast 35-miles, east 11 miles, and southeast 11 miles. A large fetch generates bigger and more powerful waves making it difficult to stabilize land with living shoreline treatments utilizing reduced or no stone structure.

The licensee redesigned the groin after initial opposition from MDE reducing its length and relocating it 125 feet away from Ms. Anderson's property line. The design as before the Board in this item falls within the design parameters MDE typically follows for groin location and length in consideration of abutting waterfront properties. This design was approved by MDE. The U.S. Army Corps of Engineers reviewed and approved this project and issued a General Permit on April 5, 2021. The Department of Natural Resources had no concerns with the project.

Mr. Harris is proposing a 41.66 linear foot groin in lieu of a 225 linear foot stone revetment that would utilize far more stone than the groin. The Wetlands Administrator agrees with MDE that the groin footprint is favorable ecologically compared to the larger impact of a revetment or breakwater along 225 linear foot of shoreline. MDE and the Administrator concur that the Board of Public Works should grant this license.

Wetlands License - #19-0200(R1) – Chesapeake Yacht Club, Inc. Modification

**Recommendation:** The Board of Public Works Wetlands Administrator recommends the Board approve a modification to Tidal Wetlands License No. 19-0200, to expand marina services within the existing Chesapeake Yacht Club Marina basin. The modification includes changes to the number of pilings, dimensions of piers, dimensions of gangways, dimensions of platforms, platform types, type of piers, pier construction and dimensions, mechanical dredge area dimensions, and dredge material transport location.

- *MDE*: The Department of the Environment concurs with this recommendation.
- *Authority*: Title 16, Environment Article, Annotated Code of Maryland; COMAR 23.02.04.17D.

**Background:** The Maryland Food Center Authority seeks to grant a right-of-way to Baltimore Gas and Electric Company (BG&E) for the purpose of installing a natural gas gate station and associated utilities. The right-of-way will be located on property under a ground lease with MORF 1 LLC that is currently constructing an anaerobic digester which will produce natural gas. Reference is made to Secretary's Agenda, Item 20 (February 7, 2018) where the Board approved the ground lease to BTS Biogas LLC for use as an anaerobic digester. MORF 1 LLC, a Maryland limited liability company, is the current tenant and was assigned the Ground Lease by BTS Biogas LLC through a lease assignment and assumption dated April 29, 2020. Since both companies are under the common ownership of Bioenergy Development Group Holdco, LLC, the assignment was allowed under the terms of the Ground Lease.

**Remarks:** This is the eighth of several deferred maintenance/site improvement projects. This project is for the replacement and the addition of sub-meters throughout campus buildings to improve the tracking and management of utility consumption. Utilities included are electricity, natural gas, chilled water, steam hot water, domestic water, and irrigation systems. This work is a part of the overall energy management and sustainability program being embarked upon by Morgan State University.

The University partnered through a Memorandum of Understanding with the Maryland Clean Energy Center (MCEC), an instrumentality of State with the mission to advance the adoption of clean energy products, services, and technologies that create jobs and positive environmental benefits for Maryland. MCEC is tasked with assisting the University to engage appropriate and qualified vendors and contractors to achieve the desired outcomes associated with this initiative.

At the request of Morgan State University, MCEC developed and executed a Request for Qualifications process to identify and select a vendor with the appropriate experience to enter into a Master Services Agreement with MCEC to provide services to the University. Only the nine vendors that have been pre-vetted for the State of Maryland Indefinite Delivery Contract (IDC) were invited to respond to the RFQ process. All nine companies responded with written proposals and those proposals were considered through a rigorous evaluation process to narrow the field to three vendors invited to give an oral presentation. Representatives from the University and MCEC were included on the evaluation committee. This group selected Siemens as the most qualified and desirable among the final three vendors.



#### Remark (cont'd):

MSA and the CM conducted pre-bid and site visit meetings at the project site, and all attendees were provided with summary project information and afforded the opportunity to tour the project site. Additionally, the project was presented virtually to conduct outreach and networking opportunities on August 4, 2021 and was attended by MSA, numerous trade contractors, and other representatives and agencies regarding contracting, MBE participation, and local hiring opportunities.


On August 12th, 2021 competitive, sealed trade contractor bids were received and opened at the CM's offices in Timonium. Post-bid scope review meetings were conducted virtually, and all bid openings and scope reviews were attended by MSA. The CM received nine bids for the bid package advertised.

Efforts to maximize Maryland's commitment to protecting the environment and incorporating green building standards to reduce the effects on climate change resulted in the project attaining 30% water use reduction, 27% site storm water runoff reduction, and 32% energy savings by using efficient MEP systems, fixtures, and equipment.

## 20. <u>MARYLAND STADIUM AUTHORITY</u> Built to Learn Act Revenue Bonds, Series 2021

**Recommendation:** That the Board of Public Works approve: 1) the Maryland Stadium Authority issuing a series of bonds in a principal amount not to exceed \$520 million (the "Series 2021 Bonds"); the proceeds of which will be used to partially finance the construction of public school facilities in six counties in Maryland (collectively, the "2021 Project"), and 2) a Comprehensive Plan of Financing, which was approved by the Stadium Authority Board on August 3, 2021 and submitted to the Fiscal Committees of the General Assembly for review and comment on August 6, 2021

Authority:Sections 10-628 and 10-649, Economic Development Article, Annotated<br/>Code of Maryland (Chapter 20 of the Acts of 2020 of the Maryland General<br/>Assembly)

*Background:* The approval of this Item will authorize the Stadium Authority to issue up to \$520 million of its revenue bonds as Series 2021 with the proceeds to be used to:

- Pay costs related to the issuance of the bonds; and
- Pay for the design, construction, renovation, rehabilitation, equipping and furnishing of the 2021 Project

In 2020, the General Assembly passed the Built to Learn Act of 2020 (2020 Md. Laws Ch. 20) (the "Act") authorizing the Authority to issue up to \$2.2 billion in debt as limited obligations of the Authority for the construction of public school facilities throughout the State. The Act took effect upon the General Assembly's override on February 12, 2021of the Governor's veto of 2020 Senate Bill 1000 / House Bill 1300 captioned *Blueprint for Maryland's Future – Implementation*.

Debt service on the bonds is secured by the Supplemental Public School Construction Financing Fund (the "Financing Fund") established under the Act. The Act provides that, in accordance with State Government Article § 9-1A-30, the Comptroller shall deposit a portion of the money in the Education Trust Fund into the Financing Fund as follows: (i) \$60,000,000 in fiscal year 2023; and (ii) \$125,000,000 in fiscal year 2024 and each fiscal year thereafter.<sup>1</sup> The limitation on debt service for bonds issued for public school construction under the Act, and the actual amount of bond proceeds available to each county, including Baltimore City, is further subject to certain terms and conditions with respect to a possible public-private partnership between the Prince George's County Government and its Board of Education with a private entity to enhance the delivery of public school construction in Prince George's County (*see Education Article § 4-126.1*).

<sup>1</sup> The \$30,000,000 deposit required by the Act in FY 2022 did not occur as a result of the delayed effective date of the bill.



#### Background (cont'd):

Pursuant to the Act the Interagency Commission on School Construction (the "IAC") is required to approve public school construction on a rolling basis with the first approved projects to be funded from the Financing Fund being those the IAC has deemed eligible for funding but State funding for the projects has been deferred due to fiscal constraints. The 2021 Project represents the IAC's approval based upon the eligibility criteria and priorities set forth in the Act and the concurrent approval of the Authority.

Bonds issued under the Act will not constitute a debt, liability, or pledge of the faith and credit or the taxing power of the State, the Authority, or any other governmental unit.

Alternate No. 2 provides two (2) years of licensing/support on the Smart Restroom Software. Alternate No. 2 is not being awarded as the pricing from both offerors exceeded the budget and therefore determined not to be fiscally advantageous to award.

The solicitation was advertised on eMaryland Marketplace Advantage and the Maryland Department of Transportation Maryland Aviation Administration's (MDOT MAA) website. The MDOT MAA directly solicited six (6) prospective offerors. The solicitation was sent to the Governor's Office of Small, Minority & Women Business Affairs and five (5) minority business associations. Three (3) proposals were received; one (1) proposal was rejected.

After BAFO No. 1 was issued requesting clarifications to the proposals, one offeror emailed the Procurement Officer a letter to formally withdraw its offer. Additionally, the same offeror failed to submit its response to BAFO No. 1.; therefore, the non-responding offeror's proposal was deemed not reasonably susceptible of being selected for award. The MDOT MAA Procurement Officer rejected the proposal; no protest was filed.

After completing technical evaluations, the panel ranked The Whiting-Turner Contracting Company (W-T) the highest technically considering the combination of industry-leading expertise, key staff, economic value to the State, and comprehensive understanding of MDOT MAA project goals.

Overall, both offerors could complete the project boasting a robust airport portfolio, which demonstrates a clear ability to perform in an airport successfully. Headquartered in Maryland, with local offices in the region, both offerors provide substantial economic benefits to the State. However, based on a combination of its technical and financial offer, the panel has determined that W-T provides the most advantageous offer to the State.

Whiting-Turner Contracting Company is exceeding the 23% MBE participation goal by 1.88%.

**Requesting Agency Remarks:** The Maryland Department of Health (MDH) launched its nationally recognized statewide contact tracing program in June 2020 in response to the urgent need to stop the spread of COVID-19. Maryland's contact tracing program is a collaborative program led by MDH in coordination with Maryland's 24 local health departments (LHDs) and supported by a virtual call center managed and staffed by the National Opinion Research Center (NORC) for case investigation and contact tracing. The LHDs are heavily dependent on the services provided by NORC and without NORC's support, would only be able to investigate and advise isolation for a small proportion of cases and contacts and COVID-19 transmission would occur unchecked. Between June 15, 2020 and July 31, 2021, the contact tracing program initiated outreach to a total of 890,406 COVID-19 cases and their close contacts, and completed interviews for 578,004 individuals. NORC's services during this time cost \$27 million (\$30/outreach) and their activities allowed LHDs to focus on outbreak investigation and high-risk settings. With increased testing due to K-12 screening and federal mandates, we anticipate that additional funding will be needed to address increased use.

MDH is exercising the first option and funding so that the contractor will continue to operate a call center that enables interviewers provided by the contractor to communicate via telephone or other means on a daily basis with cases and contacts, document the results of those communications, and apply criteria supplied by the Department to guide additional actions for each case or contact.


**Requesting Agency Remarks:** Due to an increased number of construction projects, the number of premiums has increased. In addition, the actual cost for each premium has increased due to an escalation in the insurance markets. The contract was originally executed based on estimated construction projects valued at \$290,000,000. The number is now projected at \$420,000,000. Some of the projects that were not originally accounted for when the contract was initiated include the Riverside Heavy Maintenance Building (approx. \$50m) and the Kirk Bus Facility (approx. \$63m). MDOT MTA is required to cover losses and claims that are under the deductible threshold and these costs were not accounted for when the contract was initially executed. As a result of these changes, additional contract authority is required.



**Requesting Agency Remarks:** A notice of availability of a Request for Proposals (RFP) was posted on the DGS Web Site and *eMaryland Marketplace Advantage.com* on November 12, 2020, electronically notifying approximately 273 potential vendors. Copies of the solicitation notice were sent directly to 13 prospective vendors. Three proposals were received in response on February 11, 2021.

One prospective vendor decided not to submit a proposal because they do not have the resources available due to other commitments. Another prospective vendor decided not to submit a proposal because MDOT MTA's system design was not compatible with the vendor's new direction to providing and implementing transit fare collection systems.

All three technical proposals were found to be responsive and deemed reasonably susceptible of being selected for award. Scheidt & Bachmann USA, Inc. offered the lowest price proposal and received the highest technical ranking. Award is recommended to Scheidt & Bachmann USA, Inc. as having the most advantageous offer for the State.

Currently, MDOT MTA accepts a wide variety of fare options including cash, magnetic stripe tickets and passes, contactless CharmCards, CharmPass mobile tickets, and tokens. The intent is to unify fare payment under a single electronic payment system, in addition to continued cash acceptance. The new system will be account-based, acting more like a credit card than a simple fare card. The current fare card adds/deducts fares from value stored on the physical card stored on a computer chip. The new system will store value in an account in the system.

This will enable seamless passenger travel between all modes and reduce or eliminate visually validated fares and improve operations. Currently, the rider shows a fare ticket or their phone to the bus operator or fare inspector who then determines if they can ride by looking at it and verifying the information. The new system will read a QR code so MTA employees don't need to look at anything. This also ensures there is a record of each time the CharmPass is used to ride and what bus or rail station it is used on. This is important to reduce fare evasion and have more accurate ridership records. It will also improve boarding speed and accuracy of validating fares.

The contractor will provide a next-generation, multimodal fare collection system that drives customer adoption, reduces fare collection costs and fare evasion, increases revenue, and improves existing fare collection operations. The incumbent is unable to meet the requirements for developing the new fare system and decided not to submit a proposal.

This contract includes a provision authorizing an extension for a total period no longer than onethird of the base term to spend funds remaining on the contract as provided in the Board of Public Works (BPW) Advisory 1995-1






**Requesting Agency Remarks:** A Request for Proposals for these services was posted on eMaryland Marketplace Advantage (eMMA) on October 12, 2020; electronically notifying approximately 48 potential vendors. Direct solicitations were also made to 20 vendors, eight of which were MBE-certified.

The purpose of this contract is to streamline and achieve efficiencies and best value within the State's petroleum supply chain from purchase to delivery, including transportation, environmental compliance, site maintenance, and related services, and to aggregate and take advantage of economies of scale for the various products and services required for state agencies and other eligible public entities.

Three proposals were received prior to the deadline on January 15, 2021. Each of the offerors provided clarifications on their technical proposals requested by the evaluation committee and gave oral presentations that included an overview of the company, relevant experience, approach to the project, MBE participation, and fuel management software solutions. In the final technical evaluation, the committee determined that all offerors were technically qualified. Best and Final Offers were requested from all offerors, as provided above. Financial proposals included estimated annual fuel costs plus one-time fees for initial site surveys and fuel card system upgrades.

After receiving a debriefing on its unsuccessful offer, Mansfield Oil Company of Gainesville, Inc. (Mansfield) filed a timely protest on April 1, 2021 alleging that DGS: (1) did not properly assess the technical proposals of Mansfield and the successful offeror; (2) did not adequately document the evaluation; (3) engaged in unequal treatment among the offerors; and (4) used unstated evaluation criteria. On May 5, 2021, DGS denied the protest. On May 14, 2021, Mansfield filed an appeal of DGS's protest denial with the Maryland State Board of Contract Appeals (MSBCA). On September 16, 2021, DGS received notification from the MSBCA that Mansfield voluntarily withdrew its appeal, and it was dismissed with prejudice.

Carroll Independent Fuel, LLC (Carroll) was the highest-rated offeror on all technical evaluation criteria and demonstrated unmatched commitment to providing local service for this contract. Carroll committed to achieve the full 30% MBE goal on the contract including all subgoals utilizing Maryland-based subcontractors. Although Carroll was rated second in the financial proposal evaluation, its technical superiority more than exceeded the 4% difference from the lowest financial offer. DGS has determined that Carroll's proposal to be most advantageous to the State considering price and technical factors set forth in the RFP and is recommended for the contract award.


