Purpose of the Position

The Vice President, Chief Policy & Strategy Officer (CPSO) is a core member of the Leadership team, thought partner and key advisor to the President & CEO. The CPSO is responsible for identifying, developing, and implementing cross-sector initiatives for new growth opportunities through business development, research, and partnerships to ensure regional climate sustainability and policy solutions for the future and positive regional impact.

The CPSO combines strategic thinking, policy expertise, and sharp execution to enable PIC to reach targets, goals and attain objectives.

The CPSO will manage key staff, including, but not limited to, the Senior Officer, Programs & Impact, and the Government & Policy Officer, and work closely with government entities, agencies, partners, and the Brookings Institution Metropolitan Policy Program, to develop and manage a portfolio of collaborative projects focused on the Strategic Pillars of the organization across the San Diego region. The CPSO will also provide subject matter expertise on policy initiatives, grants, and climate resilience, and collaborate with the research team.

Essential contributions and principal responsibilities of CPSO include but are not limited to:

- Participate in developing PIC policy and strategy, according to vision established by CEO
- Establish policy agenda for PIC team and manage staff to follow through on deliverables, including working with Brookings to develop research and other projects



- Work with CEO to craft strategy and approach sustainably to grow the organization
- Strategize on effective ways to communicate PIC findings and to ensure that findings are relevant to key stakeholders
- Leverage relationships with stakeholders, government officials, and others to share PIC research and policy, secure funding, and create innovative partnerships
- Effectively communicate mission, vision, and updates to external stakeholders
- Continually envision the value of PIC in the region to make San Diego a better place with respect to climate, infrastructure, community wealth building, and affordable housing, in particular
- Create a diverse array of relationships that share PIC's mission and possesses strength to help achieve mutual goals
- Lead and implement an integrated resource development strategy to support new business growth, and bring intellectual and financial capital to the region along
- Expand and create new and innovative funding sources through strategic partnerships and programs and in close collaboration with the CEO, research team, and grant writers.
- Facilitate and drive policy driven solutions for the region
- Support a culture of innovation across the organization.
- Serve as spokesperson for PIC and articulate our mission to all external constituents.
- Work with the finance team to support informed decision-making regarding pilots, scaling, partnerships, and funding.
- Willingness and ability to raise unrestricted and restricted funds
- Support and assist in leading the Government & Agency Council
- Create and contribute to public events, seminars, and forums and communicate the impact of the PIC's work in an annual report and other relevant media.
