Dear Ms. Freeman,

Common Cause North Carolina respectfully asks your office to investigate new evidence we are providing with this letter indicating possible significant violations of North Carolina campaign finance laws committed by Louis DeJoy and others connected to his former business, New Breed Logistics.

Attached is a detailed analysis and memo by noted campaign finance expert Bob Hall that outlines a disturbing pattern of suspicious campaign contributions allegedly orchestrated by DeJoy.

Our complaint filed with the North Carolina State Board of Elections last September did not provide an in-depth analysis of DeJoy's state campaign contributions. And in your announcement in April that your office would not be opening up an investigation into DeJoy, you noted that your review of state campaign finance reports "did not disclose sufficient information to warrant a criminal investigation."

We request that you take another look given this new detailed analysis of state campaign contribution activities of DeJoy and his former colleagues at New Breed Logistics.

Among the many findings that stand out in this new research are the fact that dozens of New Breed employees who had given little or nothing to North Carolina politicians suddenly began making \$1,000 and larger donations to Pat McCrory's 2012 gubernatorial campaign; 54 executives and three of their wives donated a total of \$143,130. For 46 of the 54 employees, it was their first reportable contribution to a North Carolina candidate.

As you are aware, it is against North Carolina law to funnel money into a campaign through "straw donors" or to use company funds to make political donations. We believe the new evidence provided with the attached report is clear and compelling and should be thoroughly investigated.

## MEMORANDUM

Re: Louis DeJoy Campaign Finance Complaint

This memo is accompanied by a two-page summary of campaign contributions and a 12-page spreadsheet listing more than 350 donations that are the basis of my findings.

Recent news reports indicate the FBI is conducting an investigation into possible illegal campaign contributions that Postmaster General Louis DeJoy provided to federal political committees. David Young, a former executive at DeJoy's High Point-based New Breed Logistics, told the [Greensboro News & Record](#) and other reporters that DeJoy gave company bonuses as repayments to employees who made campaign contributions to politicians selected by DeJoy. Based on the [Washington Post's confirmation](#) of that allegation with other New Breed employees in a story published on September 6, 2020, Common Cause North Carolina filed a complaint with North Carolina's State Board of Elections and asked it to conduct an investigation of possible illegal contributions by DeJoy (and his company) to non-federal NC candidates, PACs and/or political committees regulated by the State Board and state law.

The State Board has not closed its review of the complaint, but it is disappointing to read that Wake County District Attorney Lorrin Freeman has decided there is no need for an investigation. An April 12, 2021, [Associated Press article](#) quotes Ms. Freeman saying, "Our review of what we believe to be pertinent, state campaign finance reports, did not disclose sufficient information to warrant a criminal investigation." She said she made her decision around the end of 2020 and that it "does not cut off any potential federal investigation" of federal campaign contributions.

Freeman's office is responsible for prosecuting state-level campaign violations. Her decision, based only on the "information" that campaign finance reports "disclose," appears superficial and misguided. It was apparently not based on interviews with New Breed employees and David Young, who had access to payroll records as DeJoy's longtime director of human resources. Worse, her decision publicly undermines the value of the State Board of Elections conducting its own investigation since that agency relies on her office to pursue possible criminal violations.

Furthermore, as someone who has researched campaign reports for many years, I believe a careful review of contributions by DeJoy and New Breed employees to state candidates demonstrates a compelling need for state agencies, not just the FBI, to conduct a comprehensive criminal investigation of felony campaign finance violations involving hundreds of thousands of dollars to North Carolina campaigns. I am providing this memo with the results of my research as documentation that may be useful to reaffirm the importance and urgency of the complaint filed by Common Cause North Carolina in September 2020.

In a nutshell, the pattern of campaign contributions from Louis DeJoy and New Breed employees to the gubernatorial campaigns of Pat McCrory follows the same pattern of other company owners who have been found guilty in North Carolina of funneling money through their

employees to state candidates – for example, rest home chain owner [Stephen Pierce](#) of Kernersville and [packaging company owner Rusty Carter](#) of Wilmington, as well as [video-poker operator Robert Huckabee](#) who [left the state](#) before he could be prosecuted.

In all these cases, (1) company employees or associates who had never or rarely made a state campaign contribution of over \$100 suddenly made a \$1,000 or larger contribution to a candidate; (2) they made the contribution on or about the same day as other employees who were also new donors; (3) they made the contribution to a candidate who also received the maximum amount from the company owner; and (4) the company owner funneled additional money to the candidate through family members, most likely using company money.

**Here's how that scenario played out with Louis DeJoy, his family and 60 of his employees donating \$300,000 to Pat McCrory's campaigns, mostly in clusters of large donations, while those employees gave under \$8,000 to other NC candidates or committees during 30 years.**

- DeJoy moved to Greensboro in 1997 as New Breed expanded, and state campaign finance records show that the local employees he hired over the next decade, as well as those who transferred in from elsewhere, had virtually no interest in donating to North Carolina politicians.

Only one future employee (Richard Wimmer, a CPA with Ernst & Young in 1997) had given a reportable contribution (\$100 or more) to a North Carolina state candidate, PAC or party committee in the decade before 1998; Wimmer gave a total of just \$425 from 1989 to 1998.

From 1998 through 2007, only Wimmer and 5 other New Breed employees gave a reportable contribution in state politics – a combined total of just \$1,660 over 10 years.

Meanwhile, DeJoy and his wife Aldona Vos, who raised over \$1 million for federal candidates Elizabeth Dole and George W. Bush in the decade after moving to North Carolina, gave a relatively modest amount to state candidates or party committees. From 1997 through 2007, records show DeJoy and Vos contributed \$24,845 (about \$2,000 a year) to state-regulated politics, with half of that going to local and state Republican Party committees (\$13,650). *See the spreadsheet for summary data from state campaign finance records.*

- Things began to change in 2008. DeJoy and Vos each gave the maximum of \$8,000 to Pat McCrory's unsuccessful gubernatorial campaign in 2008, and DeJoy donated \$34,000 to the NC Republican Party in June 2008 and another \$13,500 in October, for a total of \$47,500 to the NCGOP.

After DeJoy and his wife gave their maximum to McCrory, 7 employees donated a combined \$3,000 to the McCrory's campaign, all on the same day – October 23, 2008. For all 7, it was their first donation to a NC candidate.

- Contributions from New Breed employees dramatically increased when DeJoy began raising funds for Pat McCrory's 2012 gubernatorial bid. Vos became a co-chair of the campaign.

Suddenly, dozens of employees who had given little or nothing to NC politics began making \$1,000 and larger donations to the McCrory campaign. For the 2012 campaign, 54 New Breed employees (and 3 of their spouses) gave McCrory a total of \$143,130. For 46 of the 54 employees, it was their first reportable contribution to a North Carolina candidate.

- A pattern also began in which maximum contributions were given by (or in the name of) three of DeJoy family members to Pat McCrory's campaigns, on or about the same day, starting in

2011 and continuing until mid-November 2015, with each family member's employer identified as New Breed. This pattern raises concerns about whether donations were made in the names of DeJoy family members and whether corporate funds were used to make them.

A total of \$39,300 went to McCrory's 2012 and 2016 campaigns from Michael DeJoy, Frances DeJoy of Greensboro and Frances A. DeJoy of Cold Spring Harbor, NY – \$13,100 from each family member in three payments of \$4,000 in 2011, \$4,000 in 2012 and \$5,100 in 2015.

In addition, Michael DeJoy and Frances DeJoy of Greensboro are listed as donating the maximum \$12,600 to the federal Tillis Victory Committee on September 29, 2014, the same day that Louis DeJoy contributed the same amount.

- For just the 2012 McCrory campaign, Louis DeJoy, Aldona Wos and the 3 family members donated \$37,717. Combined with the \$143,130 from New Breed employees, the DeJoy network directly donated a total of \$180,847 to Pat McCrory's 2012 campaign, and the new governor showed his appreciation by appointing Aldona Wos secretary of the NC Department of Health and Human Services.

Almost two thirds of this \$180,847 went to the 2012 McCrory campaign in clusters of donations around two dates described below – November 28, 2011 and September 28, 2012. David Young, the whistleblower quoted in news accounts about DeJoy's reimbursement scheme, gave \$2,000 to McCrory on each of those days. He is in a good position to report why so many New Breed employees, like him, who had previously given next to nothing to NC candidates would act almost in unison to make large donations to Pat McCrory.

- On November 28, 2011, several months before the 2012 primary, 20 New Breed employees and 2 of their wives donated \$37,750 to Pat McCrory. Five of the 20 employees had given to McCrory on October 23, 2008. For 13 of the 20 employees, including David Young, it was their first reportable donation to any state candidate.

- In the days immediately before and soon after November 28, 2011, another 17 New Breed employees, plus 3 DeJoy family members, donated \$31,400 to Pat McCrory's campaign. It was the first time the 3 family members show up on a North Carolina disclosure report; each gave \$4,000 (the maximum) to McCrory for the primary. For 15 of the 17 employees, it was their first reportable North Carolina contribution; the other 2 employees had donated to McCrory on October 23, 2008.

- On September 27 and 28, 2012, after the primary and before the general election, 45 New Breed employees, 2 of their wives, Louis DeJoy and 3 other DeJoy family members donated \$88,500 to Pat McCrory.

Most of these donors had contributed to McCrory before 2012, but 15 of the 45 employees were new donors who gave between \$500 and \$2,000 and who had never before made a reportable North Carolina campaign donation.

- Louis DeJoy sold New Breed to XPO Logistics in 2014, but he remained actively involved in managing employees as chief executive officer of the supply chain division. A September 2014 [announcement that XPO Logistics filed](#) with the Securities and Exchange Commission said, "As chief executive of XPO's new contract logistics business, Mr. DeJoy will continue to lead the operations he has been instrumental in growing since 1983."

On and around November 14, 2015, Gov. Pat McCrory re-election campaign received \$46,000 from Louis DeJoy, three DeJoy family members and 19 XPO employees.

Fifteen of the 19 employees had donated previously to McCrory; 4 were new donors who each gave \$1,000, which was their first reportable contribution in state politics.

- Louis DeJoy retired from active management and joined the board of directors of XPO Logistics in December 2015, according to a [company announcement](#).

In December 2015, Heather Clarke, DeJoy's executive assistant at New Breed and XPO, donated the maximum \$5,100 contribution to Gov. McCrory's primary campaign, after DeJoy had given the maximum in November 2015.

Clarke also gave the then-maximum of \$4,000 to McCrory for the 2012 general election at the same time her boss maxed out to McCrory, and she donated the maximum of \$12,600 to the Tillis Victory Committee on September 29, 2014, the same day that DeJoy gave that amount.

Clarke is DeJoy executive assistance in his position as U.S. Postmaster General and she has long served as secretary-treasurer of the Louis DeJoy and Aldona Wos Family Foundation. The pattern of executive assistants making donations after, or at the same time, the boss maxes out is another clue that the boss may be illegally funneling money via "straw donors" to candidates.

- During 2016, Louis DeJoy continued supporting Gov. McCrory's re-election with a \$5,100 maximum donation for his general election, a \$25,000 donation to the NC Republican Party, and a \$10,000 donation to the post-election Pat McCrory Legal Defense Fund to support bogus claims of voter fraud in an effort to overturn McCrory's loss to Roy Cooper.

In October 2016, 19 employees gave a total of \$32,100 to McCrory's campaign, led by a \$5,100 donation from Ashfaq Chowdhury who succeeded DeJoy as chief executive officer of XPO's supply chain business. This cluster may indicate the scheme of rewarding donors with bonuses continued for a time after DeJoy shifted positions to join XPO's board of directors. Ashfaq Chowdhury contributed \$15,600 to McCrory's 2012 and 2016 campaigns, more than any other New Breed or XPO executive, except Louis DeJoy.

- After 2016, Louis DeJoy made several large donations to state candidates and party committees, including \$5,400 donations each to Justice Paul Newby's campaign for chief justice and Jim O'Neill's campaign for attorney general. He is described on campaign reports as "president, LDJ Global Strategies." Significantly, no New Breed/XPO employee contributed to these candidates.

In fact, from January 2017 through December 2020, only 5 current or former New Breed/XPO employees who had joined DeJoy in making earlier donations contributed more than \$50 to a state candidate, PAC or party committee; they gave a total of only \$1,850 during those four years. Richard Wimmer, who was the only pre-1997 donor, left XPO in 2016 and donated \$750 of this \$1,850 total during 2017-2020.

**Put another way, the 60 New Breed/XPO employees who put \$209,155 into Pat McCrory's gubernatorial campaigns donated only \$1,850 in state politics during the four years after 2016; remarkably, 55 of the 60 employees, including Chowdhury and other top XPO executives, gave no reportable NC donation after 2016.**

- This absence of political activity by these New Breed/XPO employees is another indication that their large donations to Pat McCrory were tied to the power of their boss, Louis DeJoy. State

records show that besides their donations to McCrory, these 60 individuals gave a total of less than \$8,000 over 30 years to North Carolina candidates or political committees. This low level of giving from 1989 through 2020 is shown on the three columns headed “NC Giving” on the attached spreadsheet.

One more indicator: I found 14 other New Breed/XPO employees who contributed to North Carolina politics between 1997 and 2017 without any apparent coordination with DeJoy, and none of them gave a 20-year total of more than \$350 to a state-level candidate or state party committee while DeJoy led New Breed or the supply chain division of XPO Logistics. In other words, if the employee wasn’t giving in conjunction with DeJoy, they gave hardly anything to NC politics. The only outlier is one employee, a Democrat, who contributed thousands of dollars to his own losing campaign for county commissioner and hundreds more to his local party committee.

The State Board of Elections does not have jurisdiction over federal contributions, but an examination of 2014 donations by New Breed/XPO employees to Thom Tillis’ campaign for U.S. Senate against Sen. Kay Hagan provides two more examples of DeJoy’s controlling influence over his employees’ political giving.

- On September 29, 2014, 17 New Breed employees (plus 4 of their wives) donated to the Thom Tillis Victory Committee, along with Louis DeJoy and two other DeJoy family members; altogether, they contributed \$198,800 on that day.

The contributions ranged in size from \$2,400 to \$12,600 (with \$10,000 of the largest donations transferred the next day to the NC Republican Party’s federal committee to help elect federal candidates and \$2,600 transferred to the Thom Tillis Committee).

All 17 of those New Breed employees had previously joined DeJoy in contributing to the 2012 state campaign of gubernatorial candidate of Pat McCrory. Sixteen of the 17 also joined DeJoy in donating to Pat McCrory’s 2016 campaign. Like DeJoy, none of the 17 had given to Thom Tillis during his campaigns as a state Representative and NC House Speaker.

- On October 8, 2014, 20 New Breed employees donated \$37,600 to the Thom Tillis Victory Committee, bringing the total to \$236,400 from DeJoy’s employees and family members.

All 20 employees were different from the 17 who donated on September 29. Their contributions ranged in size from \$1,000 to \$2,600.

Of these 20 New Breed employees, 14 had previously joined DeJoy in contributing to the 2012 gubernatorial campaign of Pat McCrory; 5 of the other 6 had never made a reportable donation in North Carolina before their \$1,000 federal donation to support Tillis.

Like DeJoy, none of the 20 donors had given to Thom Tillis during his campaigns as a state Representative and NC House Speaker.

After its examination of federal and state campaign reports, the Washington Post reporters concluded, “Between 2000 and 2014, 124 individuals who worked for the company together gave more than \$1 million to federal and state GOP candidates. Many had not previously made political donations, and have not made any since leaving the company, public records show. During the same period, nine employees gave a combined \$700 to Democrats.”

Taken together, this pattern of highly suspicious contributions justifies a comprehensive

investigation – including subpoenaed bank account and payroll records – of state campaign donations made in the name of Louis DeJoy, his family members and New Breed employees, especially from 2011 through 2015.

The use of company funds to make, reimburse or pay for a campaign contribution violates North Carolina General Statute 163-278.19(a), and making a contribution in the name of another person or funneling money into a campaign through another person violates NCGS 163-278.14(a). In addition, NCGS 163-278.27(c) says that a business, organization or individual “who intentionally violates G.S. 163-278.14(a) or G.S. 163-278.19(a) and the unlawful contributions total more than ten thousand dollars (\$10,000) per election is guilty of a Class I felony.”

There is no statute of limitation for prosecuting a Class I felony.

I hope the information above and the attached spreadsheet will help convince the State Board of Elections and District Attorney Lorrin Freeman that a rigorous investigation of criminal wrongdoing is timely and urgently needed.
