Re: Clean Air Act Notice of Intent to Sue pursuant to 42 U.S.C. § 7604(b)(2) for failure to make findings of failure to submit under 42 U.S.C. § 7410(k)(1)(B),(C) for 2008 ozone NAAQS nonattainment areas state implementation plans

Dear Administrator Regan:

On behalf of the Center for Biological Diversity and the Center for Environmental Health (collectively, "Environmental Groups"), we hereby give notice of intent to file suit against you for "failure of the Administrator [of the United States Environmental Protection Agency ("EPA")] to perform any act or duty under this chapter which is not discretionary with the Administrator." Specifically, EPA failed to carry out its mandatory duty to issue a finding of failure to submit "Serious" nonattainment area state implementation plan ("SIP") elements and publish notice of that action in the Federal Register for the 2008 ozone national ambient air quality standards ("NAAQS"). EPA has failed to perform this mandatory duty required for the nonattainment and ozone transport region (OTR) areas and elements listed in Table 1.

I. Ground-Level Ozone Pollution is Harmful to Public Health and the Environment

EPA must remedy its violation of this mandatory duty to better protect public health and native ecosystems from ozone's harmful effects. According to EPA's exhaustive scientific review, ground-level ozone pollution—commonly referred to as smog³—causes "adverse health effects that range from decreased lung function and increased respiratory symptoms to serious indicators of respiratory morbidity," such as emergency department visits and hospital admissions. A recent peer-reviewed medical study found that even short-term exposure to high levels of

ground-level ozone increases the risk of death.⁵ Those most at risk from ozone pollution are children and older adults; people who are regularly active outside, such as laborers; and individuals with pre-existing lung and heart diseases such as asthma.⁶

Ozone is also harmful to vegetation and ecosystems.⁷ Ozone can be especially harmful to sensitive vegetation—including trees such as the black cherry, quaking aspen, white pine, and ponderosa pine—during the growing season.⁸ Ozone pollution can also indirectly harm soils, water, and wildlife, and their associated ecosystems, leading to diminished clean air and water.⁹ And ozone pollution also contributes to the climate crisis, as ozone is a greenhouse gas and ozone pollution also hinders plant growth throughout a plant's lifecycle, thereby shrinking the carbon sequestration potential of plants.¹⁰

II. EPA Failed to Make Findings of Failure to Submit for SIP Elements Required for Areas Designated As "Serious" Nonattainment Under the 2008 Ozone Standards

EPA is required to determine whether a SIP submittal is administratively complete.¹¹ If, six months after a submittal is due, a state has failed to submit any required SIP, there is no submittal that may be deemed administratively complete, and EPA must make a determination stating that the state failed to submit the required state implementation plan.¹² This is referred to as a "finding of failure to submit."

On August 23, 2019, EPA classified the areas listed in Table 1 as "Serious" nonattainment for the 2008 ozone NAAQS. ¹³ All elements of the nonattainment SIP were due by no later than August 3, 2020, with the exception for RACT measures not tied to attainment, which were due March 23, 2021. ¹⁴

As of the date of this letter, the states in Table 1 have failed to submit "Serious" nonattainment and OTR SIPs for the areas and elements listed. As required under 42 U.S.C. § 7410(k)(1)(B),

EPA had six months after the states' deadlines to issue findings of failure to submit. Here, EPA's mandatory duty passed on February 3, 2021 for all elements except RACT measures not tied to attainment, and September 23, 2021 for RACT measures not tied to attainment. EPA has thus violated its mandatory duty under the Clean Air Act to issue a finding of failure to submit.¹⁵

Without a submittal addressing the nonattainment SIP elements, the minimum criteria cannot be met for the states in Table 1 to submit a SIP addressing the Serious nonattainment requirement. EPA must therefore issue a finding of failure to submit for the nonattainment areas listed below.
