Dear Speaker Pelosi,

The HEROES Act, introduced yesterday in the House, includes critical supports to stabilize families and communities -- including expansions in access to paid sick and family leave, getting cash to families, additional nutrition benefits, and investments in housing assistance -- yet the legislation falls woefully short on support for child care.

The investments provided in this bill for child care are not sufficient to meet the bill's goals of honoring our heroes, supporting families, safely reopening our economy, and restarting businesses. The HEROES Act provides only \$7 billion in dedicated funding for child care through the Child Care and Development Block Grant (CCDBG), far below what is needed. In fact, if spent immediately to address the full range of families', providers', and educators' needs, this funding level would not even cover a full month of estimated stabilization costs.

Previous investments, including the \$3.5 billion in the CARES Act for CCDBG, have been important in supporting states to take initial steps in stabilizing child care. At the same time, states need additional funding to meet the full range of needs in the child care sector for the duration of this crisis. Additional, specific, targeted funding of at least \$50 billion is needed to stabilize our child care system, and the funding provided in the HEROES Act does not go far enough in providing the immediate relief critical for the survival of the industry.

The stakes are high if this level of relief is not provided. Our nation's child care system is on the brink of collapse, with serious implications both now and in the future. Already, we have seen job losses of over 330,000 child care workers<sup>2</sup>, providers permanently shutting their doors, and families struggling to make child care payments while they lose jobs or income. Without sufficient relief, there will not be a child care system to return to as we look to rebound from this crisis. Parents, especially women, will not have the care they need to go back to work or school, employers will be unable to restart without workers, and our economic recovery will be jeopardized.
