Okwayenziwa yiSakunda kanye lebhanga enkulu elizweni leReserve Bank of Zimbabwe kuhlelo lokupha abalimi uncedo kwezokulima lweCommand Agriculture

Kukhangelwa ukuhlaziya okutsha okwenziwa yi The Sentry, imali ezabhadalwa yibhangha enkulu elizweni yeReserve Bank of Zimbabwe (RBZ), zisiya kumankampani omcebisi kamongameli welizwe u-Kudakwashe Tagwirei zaqoqeka zaba ngokunye phakathi kokuthathu kwemali elinganisela inani lamadola emelika angamamiliyon angu\$280, eyabhadalwa kumakampani akhe lapho kuyenziwa uhlelo lokupha abalimi uncedo kwezokulima lweCommand Agriculture.

Ngesikhathi kuqhutshwa uhlelo lolu ngomnyaka ka 2016 kusiyafika ngo2019, inkampani kaTagwirei yeSakunda Holdings, yabhalwa imali elinganisa inani lamadola emelika ayi-\$1.28 bhiliyon—imali ebanjwayo (cash) yayilinganisa inani lamadola \$230 miliyon njalo edlula \$1 biliyon yohlobo wama-Treasury Bills—kodwa bathenga ezokulimisa ezilen-thengo wamadola emelika angu-1 biliyon kuphela: kusala enye imali efikha \$280 miliyon yamadola emelika.

Eyinye ingxene yemali eb-olekwa nguhulumende ku-maTreasury Bills (T-Bill), elinganisa inani lamadola US\$366 miliyon, eyabhadalwa ngenyanga kaZibandlela ngo2019, yasetshenziswa hatshi ukuthenga inhlanyelo kumbe ifethalayiza kodwa yasetshenziswa ukuthengela ihulumende lamabutho imigodi yegolide le-platinum.

Ingxene yemali ebokewisa uhulumende eku maTreasury bills, yathengwa yi-RBZ it-shintshwa ngemali ebanjwayo ngezinga eliphezulu kulalo elisemthethweni obekwe ngo-Nhlolanja 2019 njengoba umthetho lo wayesuyehlise izinga lokutshintshanisa ledola leMelika kumpahla zohlobo lolu. Izigwalo zezikwelede zelizwe zitshengisa ukuthi kukanti abanye babebona izinga ledola lemelika lemali zabo liyehla, i-RBZ yavikela imali ekuma Treasury Bills kaTagwirei ekungehlisweni kwezinga lapho

etshintshwa. Ibhanga lezwe lahambisa amadola eZimbabwe kumabhizimisi akhe ayedlula inani okwakumele lithunyeze ngokubekwa komthetho omusha. Isinqumo lesi senza ukuthi imali elinganisa inani lamaliliyoni amadola eMelika angu\$50 njalo futhi isiya kumamiliyon angu\$100, ingene esikhwameni samankampani kaTagwirei.

Kodwa, incwadi ezabonakalayo zitshengisa ukuthi imali ebolekwa nguhulumende Treasury Bills, yathengwa itshintshaniswa ngemali sibili ngezinga eliphezulu okwenzela ukuthi enye inkampani kaTagwirei; i-Landela Investments iyenelise ukubhadala inhlanganiso yeZimbabwe Mining Development Corporation (ZMDC), ukuthenga imigodi yegolide kanye lamashaya e-Pen East Mining—inkampani yamabutho ezwe leZimbabwe (Zimbabwe Defence Forces)—kungxenyenye yabo ekunkampani ye-Great Dyke Investments (GDI), yona ebona ngezokwemba iplatinum ehanganyelana labahlanganisi beRussia. Ngokwenzakala, ibhanga lelizwe le-RBZ, lalilungisa imali liyipa amankampani azimeleyo wodwa ukwenzela ukuthi akwanise ukuthenga impahla zelizwe. Inkampani ye-Landela, iPen East Mining, ibhanga yeRBZ kanye logatsha lukahulumende olubona ngezemali kabazange bafuna ukupha umbono wabo kundaba le.

Inkampani yeSakunda Holdings yatshela abe The Sentry ukuthi i-Treasury Bill (ile nombolo ethi ZTB365 20190109B), emali efika amamiliyoni angu \$366 amadola eMelika yaphiwa inkampani yeSakunda ekuqhube ni uhlelo lokupha abalimi uncedo kwezokulima lwe-Command Agriculture. Inkampani yeSakunda yabika ukuthi imali efika amamiliyoni angu \$110 amadola eMelika yahanjiswa ebhanga eyodwa kuphela. Kukhanya angani imali efika amamiliyoni angu\$256 amadola eMelika yafakwa kunkampani ye-Landela Investments.

'Kusigaba 44C (2), okungabalwayo phansi kwa lo mthetho' okuvezwe kusimiso (SI) 33 akukhanyi kusebenza lapha: Okusigaba leso kutsho imali zamanye amazwe ezikuma akhawunti eNOSTRO FCA kanye lemali ezibolekwa kwamanye amazwe ezabhadalwa ngemali zakwamanye amazwe. I-Treasury Bill le, yayingasomali egcinwa phakathi kwama- akhawunti emali zakwamanye amazwe. Ngaphezu kwalokho, kukanti eyinye yemali yama Treasury Bill kwakumele isetshenziswe ukubhadala abatholisimpahla bakwamnye amazwe, ezinye imbhadalo zenziwa phakathi kwelizwe phakathi kwamankampani kaTagwirei abhaliswe eZimbabwe, kanye lamankampani kahulumende kumbe inkampani elawulwa ngamabutho eZimbabwe eZDF.

Eyinye inkampani kaTagwirei, iSakunda Holdings, ingabe layo yazuza ekutholisweni kwezinga lokutshintsha imali ephezulu ngokwazana okwasetshenziswayo.

Iphepha elitshengisa ukungena lokuphuma kwemali ebanga elakhitshwa ngasese kunyanga kaNcwabakazi, mhlaka 23, 2019,

liveza imali efika amamiliyoni anguRTGS\$500 eyabhadalwa isuswa kubhanga yeRBZ isiya kunkampani yeSakunda; ichazwe ngokuthi 'EX RBZ RFB ZTBS'. Inani leli kalingeke labe liphume kusetshenziswa izinga lokutshintsha le 1:1 ngoba lokho kungatsho ukuba lemali yamaTreasury Bill elinganisa imali engamamiliyoni angu\$500 emali yeMelika, khona okunge-labufakazi balokho. Nxa izinga lokutshintsha imali lelanga lelo elasetshenziswe laliyi 1:10.3, imali ebhadalwayo yayizafika amamiliyoni angu \$48.5 emali yeMelika yengxene yamaTreasury Bills la. Lokho ngokokucabangela nje kodwa kungatsho ukuthi ibhangha lelizwe leRBZ labhadala inkampani yeSakunda imali enengi ngamamiliyoni angu RTGS\$450 eyedlula eyayidinge ka ngokusemthethweni—ilingana ngelanga lelo lemali engamamiliyoni angu\$43.7 miliyoni amadola eMelika.

Kuhlanganisa inombolo le lemali yokwengezelwa eyabhadalwa inkampani yeLandela iyafika amamiliyoni angu\$49.7 amadola eMelika okutsho ukuthi amankampani kaTagwirei kuyenze ka ukuthi amukela imali yeZimbabwe elinganisa amamiliyoni angu\$93.5 ngesikhathi kubhadalwa imali lezi.

Ibhanga lemali yamazwe wonke (International Monetary Fund), labika ukuba lensolo libhangha lelizwe leRBZ ngendlela elabamba ngayo i-Treasury Bill emali elinganisa amamiliyoni angu\$366 lokubhadala eyakwenzayo okudlula okusemthethweni okwabangela ukuwa kwamandla lokwehla kakhulu kwemali entsha yeZimbabwe kusukela ngaphakathi komnyaka ka2019— icala eliyalwe yinkampani yeSakunda.

Imali zokwazana lezibhadalo ezabhadalwa yiRBZ zabangela

ukuthi inkampani yeSakunda ithole imali enengi iphuma kuhlelo lokupha abalimi uncedo kwezokulima lweCommand Agriculture. Inkampani ye-Sakunda yatholisa impahla ezisetshenziswa ekulimeni ezilinganisa imali efika ibhili-yoni elilodwa kuphela, kukanti okubhalwe phansi kuveza ukuthi inkampani le yamukela imali efika \$1.28 bhiliyon. Inkampani ye-Sakunda, yona eyayifake umbono wayo ngaphambili-ni ngezinye insolo kayizange yenelise ukupha impendulo ngesikhathi sokudindwa kolwazi lolu.
