We are a group of about seventy social organizations, community associations, movements, collectives and social groups of the Canudos/BA (Brazil) region and surrounding areas, and we are the main entities involved with the protection of an endangered bird species, Lear's Macaw (Anodorhynchus leari), in Brazil and globally.

According to recent estimates, there are about 600 families from several local traditional communities, whose territories are legally recognized by the Brazilian State or in the process of homologation, which are being affected by this illegal construction

The enterprise in question is the illegal and accelerated construction by Voltalia Energy of the Canudos Wind Complex, carried out without the proper legal provisions, due respect for environmental legislation, and to the detriment of the rights of traditional populations. The Canudos Wind Complex is a wind energy facility, located in Bahia, Brazil, in an important site for biodiversity – designated as a Key Biodiversity Area and an Alliance for Zero Extinction (AZE) site.

The project does not meet at least three requirements set out in federal law for its implementation, namely:

ii. the publication of the Environmental Impact Report (RIMA)

iii. the holding of public hearings with the local population

As has been highlighted by the communities and by technical-scientific reports, the project has significantly affected the livelihoods of traditional populations, due to the deterioration of the caatinga biome, the displacement of families and communities, and the invasion/wrongful appropriation of community and traditional lands. These impacts are on collectively occupied territories and areas of community use. Specific impacts include the loss of areas for livestock grazing due to the fencing off of communal lands, the construction of roads and gates, and restrictions from using communal land. Together these impacts lead to further problems, including overgrazing due to decreased availability of grazing areas, which has both detrimental economic impacts for families and environmental impacts caused by intensive land use that degrades the caatinga. While local communities have requested that their communal lands be recognized as traditional lands of collective use, roughly ³/₄ of the lands are still awaiting confirmation of this designation. In the meantime, the state government made (legal and normative) decisions to make it easier for the wind project to occupy communal lands in 2020.

According to more recent estimates, there are about 600 families from several local traditional communities, whose territories are legally recognized by the Brazilian State or in the process of homologation, which are being affected by this illegal construction. It must be emphasized that since 2013, it was possible to observe land speculation processes and an increase in deforestation with the announcement of the arrival of the enterprise. By 2021, with the start of construction, it is possible to verify intensification of speculative activities and consequent increase in land prices, land grabbing, suppression of native vegetation, restrictions on the right to come and go of communities and displacement of wild animals. The project also poses threats to Lear's Macaw (Anodorhynchus leari), a wild bird endemic to the region, which, at the end of the 1970s, was estimated at only 60 individuals. The Public Ministry of the state of Bahia, Brazil, has recommended the immediate suspension or cancellation of the implementation of the wind project, due to non-compliance with federal legislation and international standards (19/07/2021). In the same vein, in March 2022, the Federal Public Ministry started a Public Civil Action demanding full compliance with the federal legislation. But the company Voltalia, with the consent and protection of the Institute of Environment and Water Resources (INEMA) of the state of Bahia, has continued to execute the project. Right now, the first phase of the construction is completed, the turbines are finished and they're waiting for the state license to start operating, which is why we ask for your urgent attention.
