

Q5 In general, which of the following would you be most comfortable with for your school district?





Q6 What are your major concerns about conducting in-person instruction? [check all that apply]





Q7 What are your major concerns about conducting distance learning? [check all that apply]






Q8 Based upon your district's current plan, which are you most likely to do:




