### **FACT SHEET** District of Columbia Gun Violence October 2016

#### Gun violence takes a devastating toll on Washington, D.C.

- From 2005 to 2014, 1,090 people were killed with guns in the District of Columbia.<sup>1</sup>
- From 2005 to 2014, D.C. had a rate of 15.36 gun-related deaths for every 100,000 people. This rate is 50 percent higher than the national average.<sup>2</sup>
- In the District of Columbia, more people are killed with guns than in car accidents.<sup>3</sup>

### The District of Columbia has some of the highest levels of gun-related crime in the country

- From 2005 to 2014, D.C. had a high rate of gun-related murders, with a rate of 13.40 gun-related homicides per every 100,000 people.<sup>4</sup>
- During 2005 to 2014, a gun-related homicide occurred every four days.<sup>5</sup>

## The burden of gun violence in the District of Columbia falls disproportionately on communities of color

• While African Americans make up close to 53 percent of the population, they account for approximately 96 percent of gun-related homicide victims.<sup>6</sup>

### Violence against women and access to guns is a lethal combination in the District of Columbia

• From 2005 to 2014, 69 women were murdered with a gun in the District of Columbia.<sup>7</sup>



In the District of Columbia, a person is killed with a gun every three days.<sup>10</sup>

From 2005 to 2014,

**240** young people under 21 were killed with a gun in the District of Columbia.

#### Young people are killed with guns in high numbers in the District of Columbia

- From 2005 to 2014, 240 people younger than age 21 were killed by gun violence in the District of Columbia.<sup>8</sup>
- With a rate of 17.16 gun-related deaths of people younger than age 21, D.C. has a rate four times higher than the national rate.<sup>9</sup>
